**Welcome and Opening Remarks ..... Mr. Warren Snead, Committee Chair**  
Mr. Snead, Committee Chair, called the meeting to order at 11:00 a.m. A quorum was present.

**Approval of November 06, 2025, Meeting Minutes\* ..... Mr. Warren Snead**  
Mr. Gregory Tinnell motioned to approve the November 6, 2025, meeting minutes. Mr. Mike King seconded the motion. The Committee unanimously approved the minutes.

**SC Works Certification Standards..... Ms. Nina Arnone**  
Every three years, WIOA requires the State Workforce Development Board to establish objectives, criteria, and procedures Local Workforce Development Boards use to access One-Stop Centers. Ms. Nina Arnone provided an overview of the process for updating those criteria and guidelines, including the Board’s responsibilities.

*Discussion:* Ms. Arnone explained that these changes would take place in PY’26. Some questions were raised about making sure that all areas provide standardization.

**Eligible Training Provider List Performance Measures ..... Mr. Spencer Rice**  
Mr. Spencer Rice, Lead Eligible Training Provider List Coordinator, provided an overview of the Eligible Training Provider List (ETPL), a statewide list of training providers and their programs of study that are eligible to receive Workforce Innovation and Opportunity Act (WIOA) funds to provide occupational training services to participants. Mr. Rice presented the findings with his research and recommended key performance indicators for the committee to consider in establishing minimum performance measurements for the ETPL.

**PY’24 Performance Overview ..... Mr. Amadeo Geere**  
Mr. Amadeo Geere, Director of Workforce Services, presented the PY’24 WIOA Program and State-specific fiscal performance measures.

*Discussion:*  
There were clarifying questions about the percentages that the states must spend and recapturing unused appropriated funds, answered more in depth by Mr. Zach Nickerson. There were also some questions about the Out of School Youth (OSY) activities and how those are addressed.
